SUBJECT: Amendment to the Professional Medical Services Agreement between the County of Riverside and Loma Linda University Healthcare

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Amendment to the Professional Medical Services Agreement; effective December 1, 2004;
- 2) Authorize the Chairperson to sign three (3) copies of the Agreement; and
- 3) Retain one (1) copy and return two (2) copies of the executed Agreement to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: On August 24, 2004, Agenda Item No. 3.57, the Board of Supervisors approved the Agreement with Loma Linda University Surgery Medical Group, Inc. for the provision of General Surgery Professional services including management and related administrative services. The Agreement was first Amended on August 28, 2001, Agenda Item No. 3.43 adding diagnostic management services to the Agreement. A Second Amendment on March 26, 2002, Agenda No. 3.32 added specialized Hepatic Surgical Services, paid on a case by case basis, to the agreement, and a Third Amendment on August 26, 2003, Agenda No. 3.38 removed diagnostic management services from the Agreement.
