SUBJECT: Amendment to the Professional Medical Services Agreement between the County of Riverside and Loma Linda University Surgery Medical Group, Inc., Otolaryngology, Head and Neck Surgery

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Amendment to the Professional Medical Services Agreement; effective January 1, 2005;
- 2) Authorize the Chairperson to sign three (3) copies of the Agreement; and
- 3) Retain one (1) copy and return two (2) copies of the executed Agreement to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: On July 26, 2002, Agenda Item No. 3.17, the Board of Supervisors approved the Agreement with Loma Linda University Surgery Medical Group, Inc. for the provision of professional Otolaryngology, Head and Neck (ENT) services in addition to related administrative and teaching services. The Agreement was first Amended on May 4, 2004, Agenda Item No. 3.20 extending the term of the Agreement to a maximum of five (5) years. This second (2nd) Amendment to the Agreement assigns all rights and responsibilities of the Agreement from the Loma Linda University Surgery Medical Group, Inc. to Loma Linda University Health Care.

This Agreement has been approved as to form by Riverside County Counsel.
