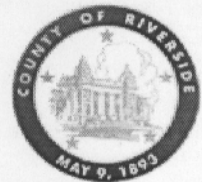

Departmental Concurrence

**BACKGROUND:** The First Amendment To Renewal Agreement with the Family Services Association of Western Riverside County (FSA), covering current fiscal year, increases by \$57,000 (FSA) reimbursable amount of \$859,766 to \$916,766. This additional Federal Funding will enhance the meals programs to seniors in Riverside County. Seniors are eligible to participate in either the Congregate Meals Program or, if homebound, the Home Delivered Meals Program. Both programs consist of the procurement, preparation, and serving/delivery of meals, as well as nutritional education and counseling.
