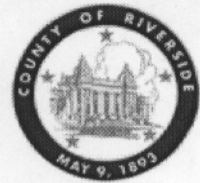

SUBJECT: HOUSING AND URBAN DEVELOPMENT GRANT AGREEMENT—PATH OF LIFE MINISTRIES

RECOMMENDED MOTION: That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for a Supportive Housing Program (SHP) Grant for \$191,565 for the period of April 1, 2005 through two years after the start of supportive services.
2. Authorizes the Chairman of the Board to ratify the attached Contract, HU 1666-00, between DPSS and Path of Life Ministries;
3. Authorizes the Purchasing Agent to sign any ministerial amendments with Path of Life Ministries, not to exceed the maximum amount of the Grant Agreement (\$191,565); and
4. Authorizes the Director of DPSS to administer the agreement with Path of Life Ministries.

BACKGROUND:

On July 1, 2003, (Agenda Item 3.49), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included funding for a new permanent supportive housing project for men with disabilities for operation by Path of Life Ministries. HUD approved the application and allocated \$191,565 for a 2-year period.

HUD executed the Grant Agreement on March 31, 2005, which we are submitting to your Board for approval along with the County's Agreement with Path of Life Ministries.

FINANCIAL DATA:

No County General Funds are required.

The budget for the two (2) years is broken down as follows: Year 1 - \$97,183; and Year 2 - \$94,382. The total amount is \$191,565.
