BACKGROUND: Adoption of Resolution No. 2005-208 appoints the Director of the Transportation Department as the Engineer to prepare a Report regarding the proposed annexation of Location 41 to Zone 3 of Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LM District No. 89-1-C").

Resolution No. 2005-209 declares the Board's intention of ordering the annexation of Location 41 to Zone 3 of L&LM District No. 89-1-C. Annexation of Location 41 to Zone 3 of L&LMD No. 89-1-C will fund the maintenance and servicing of landscaping improvements within public rights of way located easterly of Murrieta Rd. and northerly of Chambers Ave. in the Sun City area and includes 174 single-family residential parcels.

The proposed budget of fiscal year 2005-06 for Location 41 is \$13,516.00 that will result in an assessment for fiscal year 2005-06 within Location 41 of \$77.68 per parcel.

Consistent with the Board's direction regarding compliance with Article XIID of the California Constitution and the Landscaping and Lighting Act of 1972, the attached resolutions have been prepared and a public hearing scheduled for 9:30 a.m. on July 12, 2005 to receive testimony for and against the proposed assessment. Each property owner within the proposed Location 41 will receive a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2005-209 and an information sheet.

Ballots must be returned prior to the conclusion of the public hearing. If, at the time designated for the tabulation of the ballots, the ballots submitted in favor of the annexation and levy of the assessment exceed the ballots submitted in opposition of said annexation and levy, Location 41 will be annexed to Zone 3 of L&LMD No. 89-1-C.

There is only one individual/entity which owns all of the property within the proposed boundaries of Location 41 and said property owner has executed a "Waiver and Consent Regarding Date of Assessment Ballot Election" allowing for the election and public hearing to be held on July 12, 2005.
