SUBJECT: Ratify First Amendment To Renewal Agreement FY 2004/05 with AccentCare Inc. for Supportive Services Program (Personal Care And Homemaker) covering all of Riverside County.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the attached First Amendment to the Renewal Agreement with AccentCare Inc.
- 2) Authorize Chairman of the Board to sign the agreement.
- 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

BACKGROUND: The First Amendment To Renewal Agreement with the AccentCare Inc., covering current fiscal year, increases by \$10,000 AccentCare Inc. reimbursable amount of \$153,518 to \$163,518. This additional Federal Funding will enhance Homemaker & Personal Care to seniors of Riverside County. The Homemaker service provides light routine maintenance of a household, including such support as dusting, vacuuming, laundry, or meal preparation. Personal Care service will assist clients with routine care of a personal nature, such as bathing, dressing, personal appearance, feeding, and general hygiene.
