SUBJECT: Notice of Intention to Change the Name of a portion of Old Highway 86 to Harrison Street, in the Salton Sea area, Fourth Supervisorial District.

RECOMMENDED MOTION: That the Board adopt Resolution No. 2005-109, Notice of Intention to Change the Name of a portion of Old Highway 86 to Harrison Street.

BACKGROUND: Due to the construction of Highway 86S there are now two Highway 86s in this area. The State is in the process of relinquishing Old Highway 86 to Riverside County and the Highway 86 designation will go away at that time. The portion of Old Highway 86 north of 66th Avenue is already named Harrison Street and will remain named Harrison Street after the Highway 86 designation is removed. Old Highway 86 south of 66th Avenue has the Highway 86 designation only and needs to be renamed Harrison Street to be consistent with the portion to the north. The portion of existing Harrison Street south of 66th Avenue is in the process of a name change by a separate Resolution.

16 24 T. 8 S., 8 E., and Sections 19 and 30 T 8 S., R 9 E., S.B.&M, Fourth Supervisorial
17 District, to **Harrison Street**;

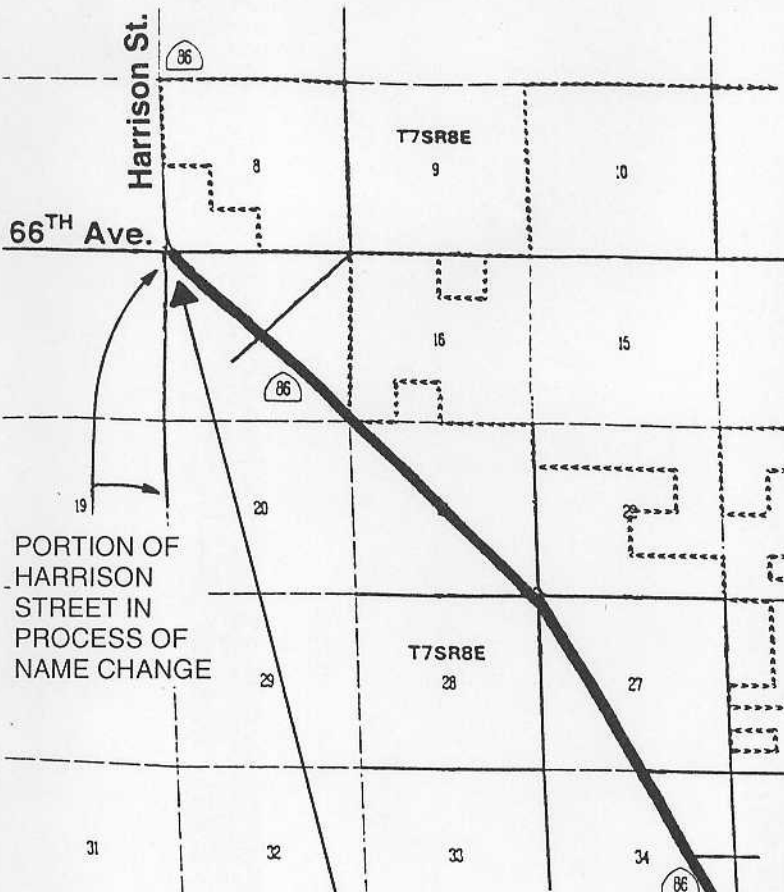

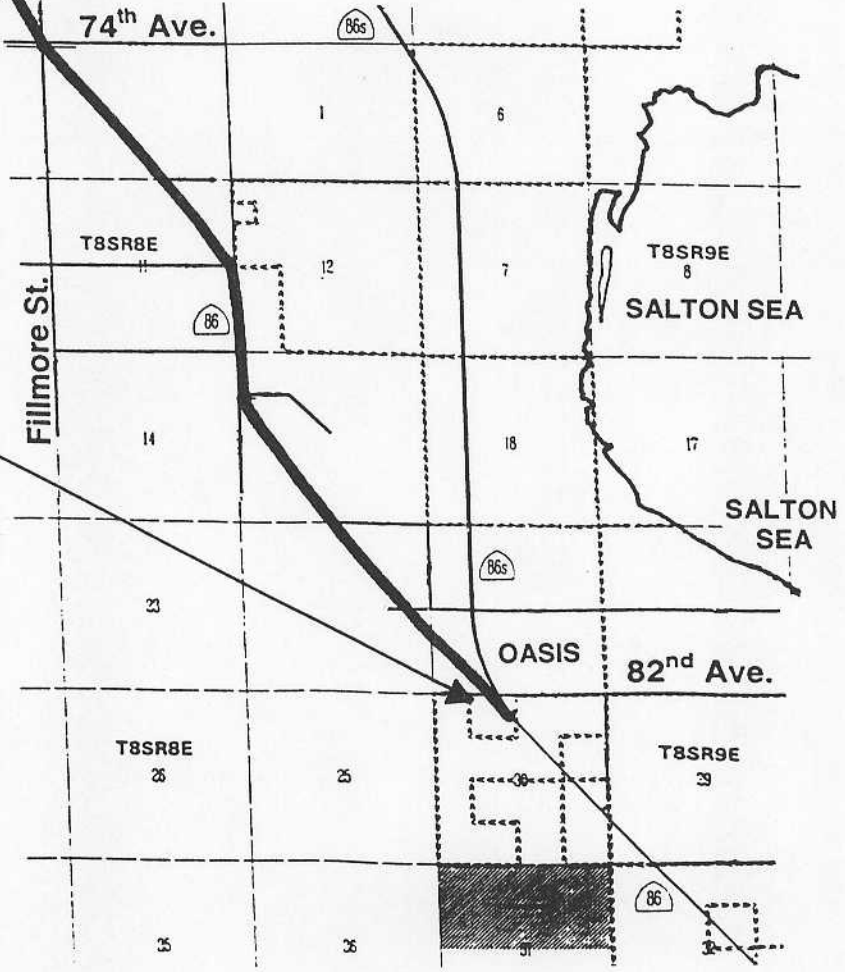
OLD HIGHWAY 86
