SUBJECT: REQUEST FOR ELECTION DATE CHANGE

RECOMMENDED MOTION: That the Board approve Beaumont Unified School District's request for election date change.

BACKGROUND: The Beaumont Unified School District has submitted the attached resolution requesting the Board of Supervisors' approval to change the District's election date from November of odd numbered years to be consolidated with the Statewide General Election held in November of even numbered years.

STATUTORY PROVISIONS: California Elections Code §§ 1302(b) and 10404.5 allow school districts to consolidate their election with the Statewide General Election with the Board of Supervisors' approval. The code further stipulates that the Board shall approve such request unless the ballot style, voting equipment, or computer capability is such that additional elections or materials cannot be handled. With countywide electronic touch screen voting, the Registrar of Voters can accommodate this change of election date.

State law also requires that within 30 days after approval of the resolution, a notice is to be mailed to all registered voters of the District informing them of the change in election date and the terms of officeholders which will be changed. The cost of this mailing will be reimbursed by the District.

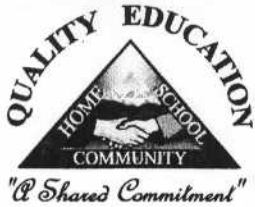

Beaumont Unified School District RESOLUTION 2005 -23

"BEAUMONT UNIFIED SCHOOL DISTRICT BOARD OF TRUSTEES TO THE RIVERSIDE AND SAN BERNARDINO COUNTIES BOARD OF SUPERVISORS RECOMMENDING CONSOLIDATED ELECTIONS FOR GOVERNING BOARD MEMBERS WITH STATEWIDE GENERAL ELECTIONS"

WHEREAS, elections for members of the Board of Trustees of the Beaumont Unified School District, which are held on odd-numbered years, historically have had lower levels of voter participation than statewide elections in even-numbered years; and

WHEREAS, elections for Governing Board members are not held in conjunction with other elections, and as a result the District must bear the expenses of the elections, and those expenses are proportionally higher than if the elections were consolidated with statewide general elections in even-numbered years; and

WHEREAS, the Governing Board of the Beaumont Unified School District desires to make every effort within its power to increase voter participation in elections for Board members, and it wishes to reduce expenses whenever possible;


NOW, THEREFORE, BE IT RESOLVED that the Governing Board of the Beaumont Unified School District requests that both the Riverside and San Bernardino Counties Board of Supervisors consolidate all further elections for Beaumont Unified School District Board members with the statewide general elections to be held in even-numbered years, beginning in November 2008.
