SUBJECT: Sub-recipient agreement between the Department of Public Social Services (DPSS) and the Housing Authority and extension of the services agreement with the Department of Mental Health

RECOMMENDED MOTION: That the Board of Commissioners:

1. Approve the sub-recipient agreement between the Department of Public Social Services and the Housing Authority of the County of Riverside in the amount of \$98,712 for the Shelter Plus Care Program,
2. Authorize the Interim Assistant County Executive Officer / EDA to execute the agreement, and
3. Authorize the Interim Assistant County Executive Officer / EDA to extend the agreement with the Department of Mental Health to provide matching supportive services for the program, and
4. Authorize the Interim Assistant County Executive Officer / EDA to take the necessary steps to implement both above stated agreement and executive necessary and related documents.

BACKGROUND: A companion related item from DPSS was approved at the Board of Supervisors agenda of 14 June 2005. The Housing Authority operates the Shelter Plus Care Program, which serves homeless and mentally ill persons in the East County area providing housing assistance and supportive services. The Shelter Plus Care Program is funded with Homeless Assistance grant funds allocated by HUD and administered by DPSS. The attached sub-recipient grant agreement between DPSS and the Housing Authority allocates \$98,712 of the Homeless Assistance HUD grant funds to the Shelter Plus Care program for the 2005 / 2006 fiscal year. The Shelter Plus Care program is administered by the Housing Authority for the benefit of homeless and mentally ill persons in partnership with the Riverside County Department of Mental Health. The Housing Authority and the Department of Mental Health entered into a Memorandum of Understanding on 28 July 1999 for the above stated partnership in operation of the Shelter Plus Care Program. The attached amendment authorizes the extension of the said MOU between the Housing Authority and the Department of Mental Health through 16 June 2006.

As such, the attached sub recipient agreement renews grant funding for the Shelter Plus Care Program for the 2005 / 2006 fiscal year and the attached amendment to the MOU extends the partnering relationship between the Housing Authority and the Department of Mental Health for the operation of the Shelter Plus Care Program for the same 2005 / 2006 fiscal year.
