4 ACCEPTING AN OFFER OF DEDICATION FOR A PORTION OF LA ESTRELLA  
5 STREET, IN THE WILDOMAR AREA, FOR PUBLIC USE  
6 (First Supervisorial District)

8 **WHEREAS**, the hereinafter described portion of La Estrella Street was  
9 offered for dedication for public road and public utility purposes by the map hereinafter-  
10 referred to, which offer of dedication has not been previously accepted by the County of  
11 Riverside, now, therefore;

13 **BE IT RESOLVED, DETERMINED AND ORDERED** by the Board of  
14 Supervisors of the County of Riverside, State of California, in regular session assembled  
15 on June 28, 2005, that this Board accepts the offer of dedication and recognizes  
16 that said road is a public road open for use by the general public;

18 **BE IT FURTHER RESOLVED, DETERMINED AND ORDERED**, that this  
19 acceptance is for the purpose of vesting title in the County of Riverside on behalf of the  
20 public for public road and utility uses, and is not an acceptance of the road into the County  
21 Maintained Road System pursuant to Section 941 of the Streets and Highways Code and  
22 that said road shall not become part of the County Maintained Road System unless  
23 subsequently accepted into said Maintained Road System by resolution adopted by this  
24 Board.

3 Said road is in the County of Riverside, State of California, and is described as  
4 follows:

6 LA ESTRELLA STREET (See Exhibit "A")

7 That portion of La Estrella Street (30 feet wide), between Susan Drive and Porras  
8 Road, shown as Lot "H" on Parcel Map No. 9789 recorded in Book 44, Page 51 of Parcel  
9 Maps on file with the Records Office of Riverside County, California.

11 **BE IT FURTHER RESOLVED, DETERMINED AND ORDERED** that the Clerk of  
12 the Board shall cause a certified copy of this resolution to be recorded in the Office of the  
13 Recorder of Riverside County, California.
