SUBJECT: Approve contract agreements with 14 contractors for FY 2005/06 covering 22 senior services in all of Riverside County.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve agreements with 14 Contractors (See Form 11 Attachment A for list of contractors).
- 2) Authorize Chairman of the Board to sign the agreements.
- 3) Direct the Clerk of the Board to retain (1) original copy of each contract and return (2) copies of each contract to the Office on Aging for further processing.

BACKGROUND: The enclosed agreements represent the first year of the four year Request for Proposal (RFP) Contracting cycle (July 1, 2005 through June 30, 2009) based on federal guidelines. The RFP process requires a public process in which the Riverside County Office on Aging requests potential contractors to bid for 22 senior services in all of Riverside County through an intense application process. Those who offer services that meet our standards and are at a rate that is competitive are approved by our Advisory Council. For this funding cycle, contractors were approved on February 16, 2005.

SUBJECT: Approve contract agreements with 14 service providers for FY 2005/06 covering 22 various senior programs in all of Riverside County.

BACKGROUND: (continued)

These agreements with the above listed contractors covering the period July 1, 2005 through June 30, 2006, in the reimbursable amount of \$4,138,178.00 continues 22 vital services to frail seniors in Riverside County. These services target seniors in Riverside County that need meals, transportation, in home service care, Adult Day Care, Caregiver Support, Respite, legal assistance, Ombudsman Services, Community Services and Senior Center Support, Income Support/ Material Aid, Alzheimer's Day Care Resource Centers and a Health Insurance Counseling and Advocacy Program (HICAP). Attachment A of the Form 11 gives a breakdown of service providers, program and service descriptions, dollar amounts, and total contract amounts per service provider.

More descriptive information regarding the contractors and services to be preformed are located in each contractor agreement under Attachment A (Scope of Work). Attachment A provides program specifications including definitions of service, unit costs if applicable, and methods of service delivery for each contractor.

These programs are funded by the Older Americans Act, Older Californian Act, and support the goals and objectives of the Office on Aging's four-year Strategic Plan: Strength in Aging. Our strategic plan was approved by the Office on Aging Advisory Council on January 18, 2005 and the Board of Supervisors on April 26, 2005 Agenda Item 3.5.

The Office of County Counsel has approved these agreements as to form.
