SUBJECT: Change the Name of Saintsbury Street to Miramonte Street, in the Temecula area, Third Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2005-256, Changing the Name of Saintsbury Street to Miramonte Street.

BACKGROUND: Recent development in this area has resulted in two streets with similar names, Saintsbury Street and Saint Tisbury Street. This name change will rectify the situation and eliminate possible confusion for emergency response. Property owners on Saintsbury Street and the Riverside County Sheriffs' Department 9-1-1 Coordinator have requested this name change. The adjacent property owners have been notified of the proposed name change; one property owner is not in favor of the name change due to the inconvenience of a change of address.
