**RECOMMENDED MOTION:**

1. Approve Amendment No. 1;
2. Authorize the Chairman to execute the Amendment on behalf of the District;
3. Direct Purchasing Department to amend the existing multi-year purchase order on behalf of the District; and
4. Authorize the District's General Manager-Chief Engineer to renew the agreement for FY 06-07.

**BACKGROUND:**

The original three-year Agreement established the terms and conditions by which the Consultant provides on-call construction inspection services to the District in support of the District's Contract Administration Section. Amendment No. 1 increases the amount of contract services from \$200,000 to \$275,000 for FY04-05 and renews the Agreement for FY05-06 in an amount not to exceed \$275,000.

**FINANCIAL:**

A portion of the cost of the construction inspection services provided by Consultant, estimated as approximately \$200,000, will be funded by those parties constructing District maintained drainage facilities as provided by County Ordinance No. 671. Services provided in support of District funded Public Works projects will be funded by each zone fund as necessary in an amount estimated as \$75,000. Sufficient funds are available in each zone fund to cover these anticipated services.
