**SUBJECT:** Resolution 413-595 to Establish a No-Stopping Zone on 34<sup>th</sup> Street, Rubidoux area

**RECOMMENDED MOTION:** That the Board adopt Resolution 413-595 to establish a No-Stopping Zone on 34<sup>th</sup> Street in the Rubidoux area, as described in attached Resolution 413-595.

**BACKGROUND:** The Transportation Department was contacted by the manager of the apartment complex located on the northwest corner of the intersection of Rubidoux Boulevard and 34<sup>th</sup> Street. The apartment manager was concerned about vehicles parking on both sides of the driveway to the apartment complex, thereby causing a sight restriction.

Transportation Department staff reviewed this location in the field and determined that the proposed No-Stopping Zone will improve sight distance at this location and is appropriate. There is on-street parking available on the south side of 34<sup>th</sup> Street for the residents of the apartment complex.

Based on this review, the Transportation Department recommends approval of this No-Stopping Zone. The Transportation Department staff has contacted the Riverside Area office of the California Highway Patrol regarding the proposed zone.

County Counsel has approved this resolution.

8 Zone is hereby established in the Rubidoux area:

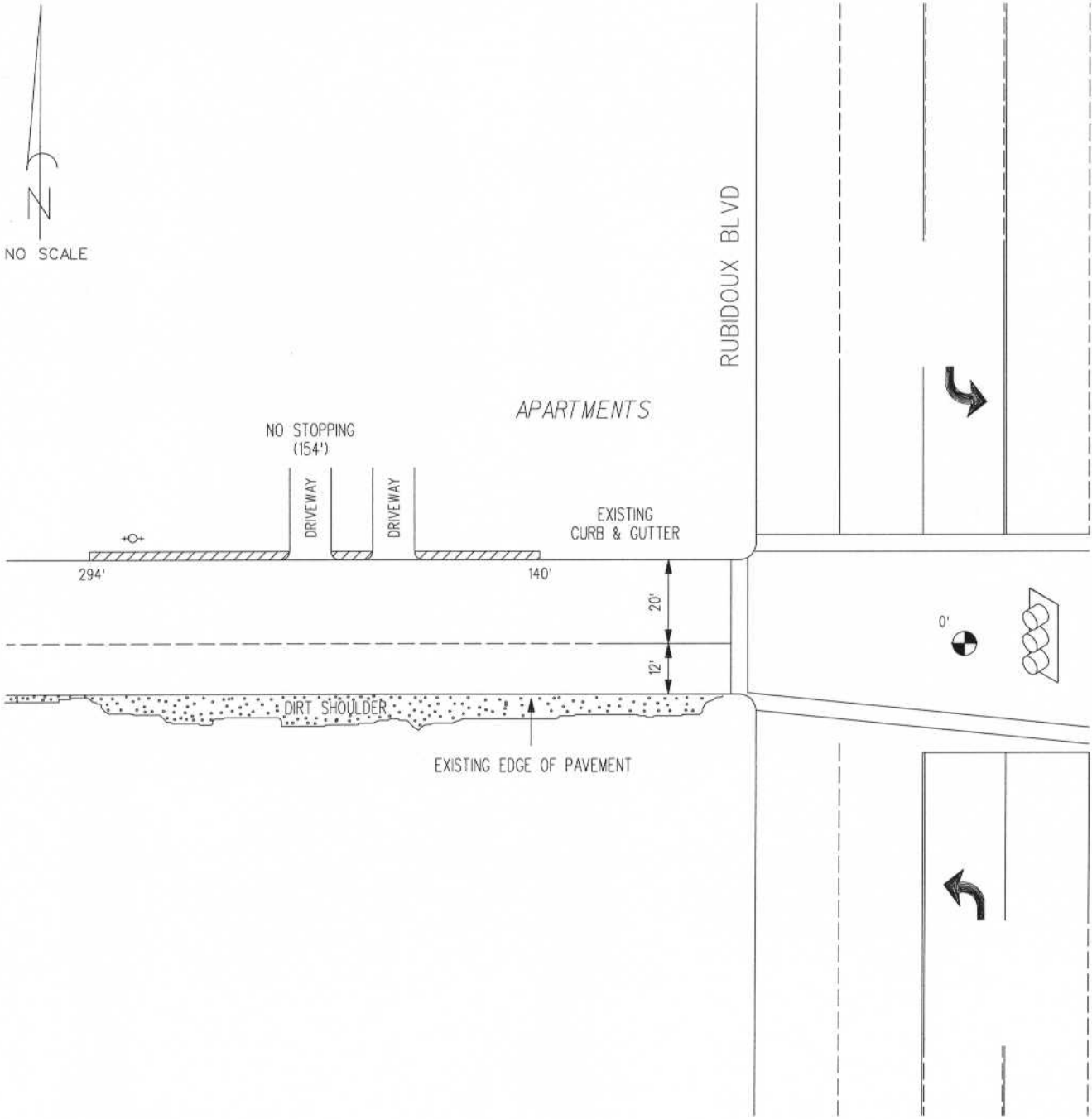
