**SUBJECT:** Agreements for Domestic Crisis and Referral Services with Alternatives to Domestic Violence and Shelter from the Storm

Departmental Concurrence

**BACKGROUND:** State statutes allow a surcharge on marriage license fees in the amount of \$23.00 to be collected and allocated to approved organizations assisting victims of domestic violence. These are commonly referred to as Presley Funds. These services are provided in the eastern part of the county by Shelter from the Storm and in the western part of the county by Alternatives for Domestic Violence. Presley Funds generate approximately \$220,000 annually, with each agency receiving one-half the available funding in an amount not to exceed \$110,000 annually. (Continued)

Conditions of probation for domestic violence crimes include a \$200 fee of which \$66.67 is collected by the County and deposited into a trust fund for domestic violence programs. This trust fund is separate from the Presley Fund. Utilizing this trust fund, the County provided through an agreement \$206,960 in FY 2003/04 to assist with start-up costs for a new facility in the western county for Alternatives for Domestic Violence to provide referral and shelter services. This agreement also allowed two additional years of funding for this new shelter at the rate of \$50 per bed night up to a total of \$110,000 per year. The attached agreement with Alternatives for Domestic Violence provides for this additional funding. While this new facility was expected to open in July 2004, it did not open until Spring 2005. The agreements are being presented for approval at this time due to the delay in opening this new facility.
