SUBJECT: Ratify the Fourth Amendment to the Agreement between Desert AIDS Project and County of Riverside Community Health Agency, Department of Public Health for HIV Testing (Contract DPH03K.024).

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Fourth Amendment to the Agreement between Desert AIDS Project and County of Riverside Community Health Agency, Department of Public Health in the increased amount of \$26,000 and total amount of \$51,000; and
- 2) Authorize the Chairperson to sign five (5) originals of said Agreement on behalf of the County.

BACKGROUND: Desert AIDS Project (DAP) has provided HIV Testing service since 1996. DAP has the facilities and experience needed to provide the optimum provision of HIV testing services for the residents of Riverside County. There has been an increased demand for HIV testing in the desert area. The increased demand is due to effective HIV outreach that encourages individuals at risk to seek testing to learn if they are infected. The State Office of AIDS will pay for the increased testing demand.
