SUBJECT: APPROVAL OF THE AMENDMENT TO THE AGREEMENT WITH CARDIO VASCULAR PLUS

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve Amendment to the Agreement with Cardio Vascular Plus and Riverside County Regional Medical Center (RCRMC), and;
- 2) Authorize the Chairman to execute the amendment, and;
- 3) Direct the Clerk of the Board to retain one original and return two (2) original copies of the amendment to Riverside County Regional Medical Center - Contract Administration for further distribution and processing

BACKGROUND: RCRMC surgeons require an experienced surgical blood recovery contractor with trained and experienced technicians for service and product support. Cardio Vascular Plus has been the contracted provider for this service, based on a request for proposal issued July 23, 2001, and approved by the Board on May 7, 2002, item number 3.37. This Amendment is to continue service while RCRMC and County Purchasing conduct a new Request for Proposal.
