BACKGROUND: On June 29, 2004, item 3.17, the Board approved the Department of Mental Health agreement with InfoMC, Inc. who supports the Department's administrative services organization system in cooperation with the Managed Care Mental Health Plan (MHP) responsibilities. The managed care mental health services provided through the MHP are authorized and payments approved, as required by law, through the utilization of this system. Additionally, this system has the appropriate state reporting requirements programmed. The department would like to renew the agreement with InfoMC, Inc. to continue uninterrupted authorizations and payment approvals through fiscal year 2005/06.

SUBJECT: Ratify Fiscal Year 2005/2006 Mental Health Agreement Renewal with InfoMC, Inc.

The contract has been increased by \$10,540 because of the increasing costs to provide system maintenance for the existing eCura Information System Product and a change in pricing model for the eCura Provider Connect product from a user license model to a subscription model.

Seven California Counties acting as a Managed Care Mental Health Plan are utilizing InfoMC, Inc. products and services to administer their Managed Care Program. InfoMC, Inc. owns the software source code used by these Counties.

This agreement is being taken to the Board now because the negotiations for the agreement renewal took longer than anticipated and the contractor returned the signed renewal on July 13, 2005.
