**BACKGROUND:**

On July 12, 2005, a public hearing was held to receive all testimony regarding the annexation of Location 41 to Zone 3 of Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LM Dist. No. 89-1-C"). After closing the public hearing, the Board directed the Director of Transportation, or his/her designee, to tally the assessment ballots that had been received prior to the close of the hearing. The assessment ballots were to be tabulated on July 13, 2005 at 10:00 a.m. in Conference Room B on the 8<sup>th</sup> Floor of the County Administrative Center. The tabulation shows that votes representing 174 parcels out of a possible 174 parcels were cast, and that 174 votes ( or 100%) were cast in favor of the annexation of Location 41 to Zone 3 of L&LM Dist. No. 89-1-C and the levy and enrollment of the special assessment.

The proposed budget for fiscal year 2005-06 for Location 41 of Zone 3 is \$13,516.00 that will result in an assessment for fiscal year 2005-06 within Location 41 of Zone 3 of \$77.68 per parcel. Location 41 of Zone 3 includes 174 single family residential parcels.

Adoption of Resolution No. 2005-379 confirms the assessment levy as indicated in the Engineer's Report for fiscal year 2005-06 for Location 41 of Zone 3 of L&LM Dist. No. 89-1-C and orders the placement of the annual assessment on the County's Assessment Roll for fiscal year 2005-06.
