SUBJECT: Blythe Sanitary Landfill Liquid Waste Pond Platform Improvement and Downdrain Construction Notice of Completion.

RECOMMENDED MOTION: That the Board:

1. Accept the construction of the Liquid Waste Pond Platform Improvement and Downdrain at the Blythe Sanitary Landfill by D. C. Hubbs Construction and authorize the General Manager-Chief Engineer to execute a Notice of Completion.
2. Direct the County Clerk to file the executed Notice of Completion.

BACKGROUND: On May 24, 2005, the Board awarded D. C. Hubbs Construction a contract to construct the Liquid Waste Pond Platform Improvement and Downdrain. The Department accepts the work and, therefore, recommends filing a Notice of Completion.

The original contract amount was \$89,999.00. The final cost of the project is \$86,199.00. The decrease is due to the as-built reduction in quantity of one of the Contract Bid Items.
