**SUBJECT:** Notice of Completion – Jacqueline Cochran Regional Airport Ramp Project

**RECOMMENDED MOTION:** That the Board of Supervisors execute and record the attached Notice of Completion of the construction for the Jacqueline Cochran Regional Airport Improvement Project.

**BACKGROUND:** On June 15, 2004, the County, by and through it's Aviation Division, entered into a contract with Granite Construction Co., for the construction of the Jacqueline Cochran Regional Airport Ramp Project. The project consisted of the construction of additional heavy duty aircraft parking ramp along Taxiway F and the installation of a lighted wind cone. The purpose of the project is to have additional parking closer to the main runway for the heavier aircraft now frequenting the airport and adjacent to a proposed terminal facility. The project was completed on May 17, 2005 and the ramp and wind cone have entered service.
