**SUBJECT:** Election Charges/Fees for Services

**RECOMMENDED MOTION:** That the Board of Supervisors introduce Ordinance No. 738.2 and conduct a public hearing on August 23, 2005, for proposed adoption of this Ordinance.

**BACKGROUND:** The existing fee schedule for services was originally developed in 1989, with adjustments in 1993 and 2000. A majority of the fees are unchanged or based on established governmental codes. The existing fee for candidate statement deposits has not kept pace with actual costs resulting in the department subsidizing the cost of candidate statements. The proposed fee increase is structured to recover the department's actual costs from the printing vendor.
