Vacation of Restricted Access Rights

Restricted access right along Parcel 3 of Parcel Map 23346 on file in Parcel Map Book 160, pages 91 and 92, Records of Riverside County, State of California, lying in Section 31 T. 7S., R. 1W. SBM, more particularly described as follows:

Access Opening:

Beginning at the most southwest corner of said Parcel 3, said point being the beginning of a non-tangent curve concave to the northwest and having a radius of 2956.00 feet, a radial line bears N 45° 10' 34" E (R); thence southeasterly along said curve through a central angle of 4° 48' 13" an arc distance of 30.00 feet to the point of **terminus**.

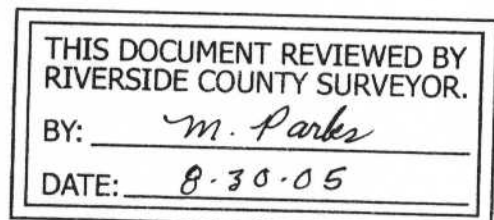


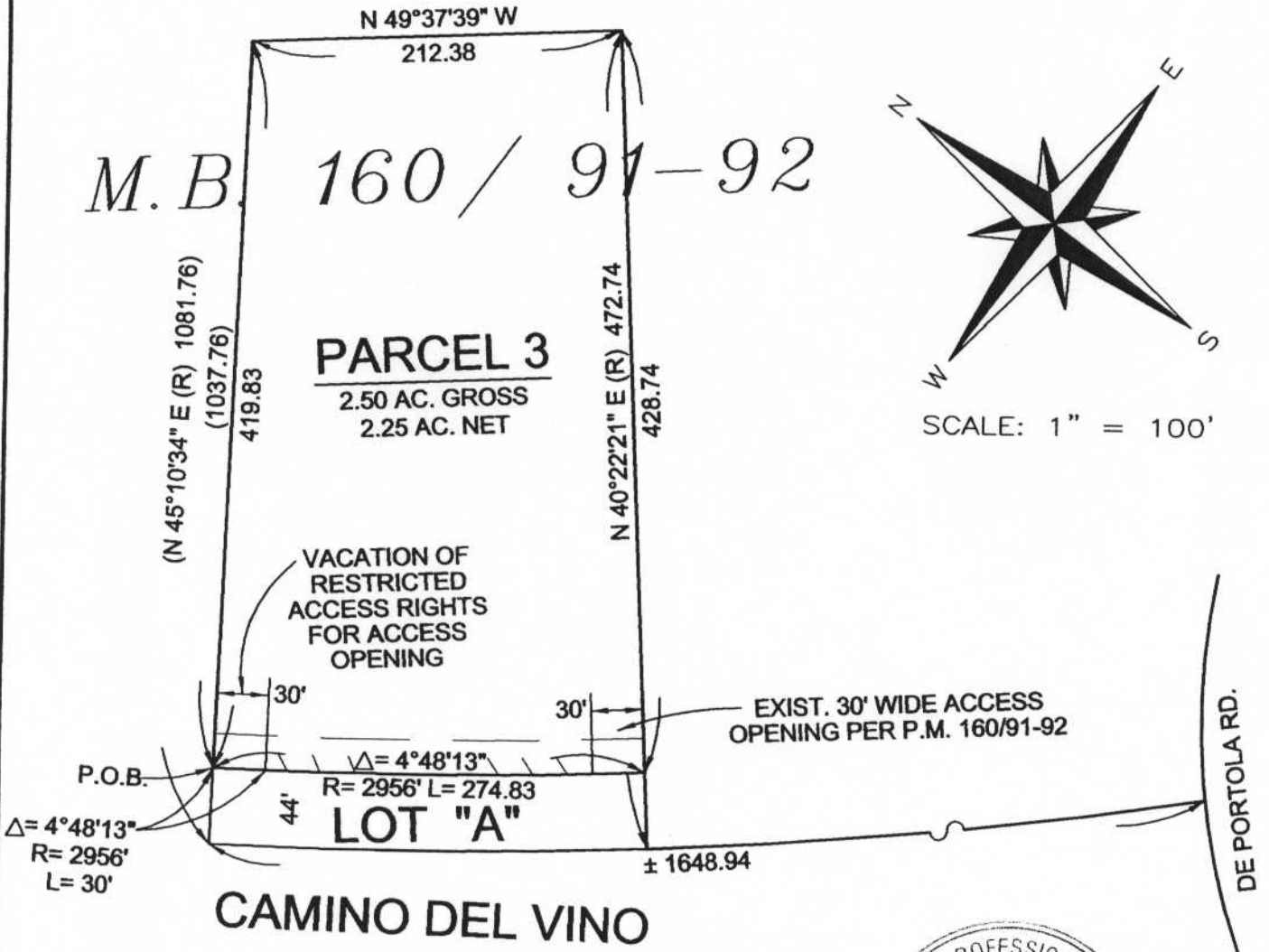
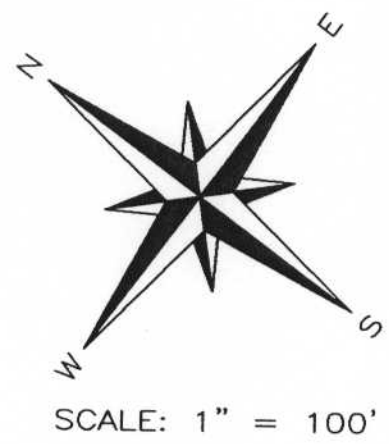
