BACKGROUND: The most recent agreements between the Department of Mental Health and Inland Mental Health Associates, Inc., dba Canyon Ridge Hospital were approved by the Board on June 28, 2005, item 3.31. These agreements provide psychiatric inpatient hospital services to emotionally disturbed minors and seriously mentally ill older adults in need of acute psychiatric inpatient hospital services covered by Medi-Cal and to indigent clients who have no funding sources to pay for these necessary services.

SUBJECT: Consent to Assignment-Inland Mental Health Associates, Inc., dba Canyon Ridge Hospital to Canyon Ridge Hospital, Inc.

BACKGROUND: Continued

Inland Mental Health Associates, Inc. (Inland), entered into an Asset Purchase Agreement with Canyon Ridge Hospital, Inc. (CRH), whereby CRH acquired substantially all of the assets of Inland that comprise the behavioral health care facility located at 5353 G Street, Chino, California 91710. This transaction closed on August 1, 2005, at which time CRH assumed ownership and operational control of the Facility.

Pursuant to the Purchase Agreement, Inland assigned to CRH all of its contractual rights and obligations in, to and under the existing agreements with Riverside County Department of Mental Health for the provision of acute psychiatric hospital inpatient services.

Under the terms of the Agreements (Section VII: Delegation and Assignment), the contractor must obtain Board of Supervisor approval before a Consent to Assignment may take place.

The Department is therefore requesting approval of the Consent to Assignment of Agreements with Inland Mental Health Associates dba Canyon Ridge Hospital to Canyon Ridge Hospital, Inc.

This Consent to Assignment has no financial impact to the Department of Mental Health.
