**SUBJECT:** The Construction of Liner System Phase 2, Stage 2 Expansion at the Lamb Canyon Sanitary Landfill – Notice of Completion

**RECOMMENDED MOTION:** That the Board:

1. Accept the construction of Liner System Phase 2, Stage 2 Expansion at the Lamb Canyon Sanitary Landfill by Road Builders, Inc., and, authorize the Chairman to execute a Notice of Completion.
2. Direct the County Clerk to file the executed Notice of Completion.
3. Authorize reduction of the project retention funds from 10 percent to 5 percent.

**BACKGROUND:** On November 16, 2004, the Board awarded Road Builders, Inc. the contract to construct the Liner System for Phase 2, Stage 2 Expansion project at the Lamb Canyon Sanitary Landfill. On July 26, 2005, construction was satisfactorily completed on time and within budget. The Department has accepted the work and the regulatory agencies have already approved the constructed liner system; therefore, the Department recommends filing a Notice of Completion. (Cont'd)
