SUBJECT: Appointment of Special District Directors

RECOMMENDED MOTION: That the Board of Supervisors appoint the qualified candidates as Directors for the respective Districts and terms as shown on Exhibit A.

BACKGROUND: The Registrar of Voters certifies that the individuals recommended for appointment are qualified candidates for the office stated, having duly filed the required documents for nomination to the respective office or recommended by the District Board of Directors.

Due to insufficient nominees, the November 8, 2005 scheduled election will not be held in the election contests listed on Exhibit A.

Pursuant to Elections Code §10515, the Board of Supervisors shall appoint any person so nominated prior to the Monday before the first Friday in December.

Palo Verde Valley Library District, Chiriaco Summit Water District and Murrieta County Water District all have vacant seats; therefore, pursuant to California Elections Code §10515(b) the supervising authority (Board of Supervisors) shall appoint a qualified person(s) to the office(s). The Districts Board of Directors has submitted letters recommending the appointment of qualified individuals to the vacant seats.






