SUBJECT: State Agreement 05-06-1 with the Heman G. Stark Youth Correctional Facility.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify State Agreement 05-06-1, with the California Department of Corrections and Rehabilitation, Division of Juvenile Justice, to provide medical and emergency services at Riverside County Regional Medical Center to the wards assigned to the Heman G. Stark Youth Correctional Facility in Chino, California, effective July 1, 2005, through June 30, 2006;
- 2) Authorize the Chairperson to execute four (4) copies of the Agreement; and
- 3) Direct the Clerk to return all four (4) executed copies to RCRMC Administration. Upon final approval, a fully executed Agreement will be returned to the Clerk of the Board.

BACKGROUND: The Department of Corrections and Rehabilitation, Division of Juvenile Justice, has agreed to renew a contract with Riverside County Regional Medical Center (RCRMC) to provide inpatient/outpatient, medical/surgical hospital services for juvenile justice inmates assigned to the Heman G. Stark Facility located in Chino, California.
