**RECOMMENDED MOTION: APPROVE** the Cooperative Agreement between the County of Riverside, (County) Riverside County Flood Control and Water Conservation District, (District), HHI Hellman, LLC (Developer); and **AUTHORIZE** the Chairman to execute the Agreement documents on behalf of the County.

**BACKGROUND:** The Agreement sets forth the terms and conditions by which certain Flood Control facilities, required as a condition of approval for Tract 31476 are to be constructed by the Developer and inspected, operated and maintained by the County and the District.

Upon completion of the project construction, the District will assume ownership, operation and maintenance of the mainline storm drains. The County will assume ownership, operation and maintenance of the associated catch basins, laterals and connector pipes located within its rights of way.
