RECOMMENDED MOTION: That the Board ADOPT Resolution No. 476, authorizing (1) the filing of a report for State Subventions on Agricultural Preserves, and (2) designating the County Assessor-Clerk-Recorder Larry Ward as the authorized representative for the purposes of the said filing.

BACKGROUND: The annual subvention report substantiates allocated acreage of prime and non-prime agricultural land contracted under the land conservation act. The results of this report determine monies allocated to Riverside County for revenue because of reduced contracted land values. Department of Conservation regulations 14102 (c) and 14111 (a) set forth the requirements of a resolution by the Board of Supervisors authorizing the filing of the report and designating an authorized representative to file on its behalf.
