**SUBJECT:** Agreement to Reimburse the County for the Provision of a Sheriff's Lieutenant to the Commission on Peace Officer Standards and Training Research Project and the Adoption of Resolution 440-8630.

**RECOMMENDED MOTION:** Move that the Board of Supervisors:

1. Approve the Agreement with the Commission on Peace Officer Standards and Training to reimburse the County for the provision of a Sheriff's Lieutenant to consult on a study of the reading and writing requirements for entry-level peace officers, and authorize the Sheriff to sign all copies of the Agreement.

2. Amend Ordinance No. 440 pursuant to Resolution 440-8630 submitted herewith. Per the Resolution add the following position:

**BACKGROUND:** The Commission on Peace Officer Standards and Training (POST) is about to initiate a yearlong Reading and Writing Research Project. The project's goal is to set statewide standards of competency in reading and writing for all peace officer recruits. POST has asked the Sheriff's Department if it could provide a Lieutenant, familiar with officer training, to research best practices for reading and writing assessment, act as a liaison between the project and the law
