**SUBJECT:** *First 5* Grant for *Project Read with Me* School Readiness Project

**RECOMMENDED MOTION:** That the Board:

- 1) Accept the *Project Read with Me* grant from *First 5 Riverside* in the amount of \$186,750;
- 2) Approve the budget adjustments and direct the Auditor-Controller to make the required budget adjustments; and
- 3) Authorize the County Librarian to execute any required documentation for the above grant award.

**BACKGROUND:** Riverside County Library has been awarded funds from *First 5 Riverside* to continue *Project Read to Me*, a program which fosters school readiness through one-on-one reading to preschool children in the home. This \$186,750 award represents an increase in funding of \$33,050 from the previous year's grant, for the purpose of expanding *Project Read to Me* to serve 1750 children in 33 participating child care centers located in the communities of Mecca, Coachella, Indio, La Quinta, Desert Hot Springs, Thousand Palms, Rubidoux, Lake Elsinore, San Jacinto, Perris, Hemet, and other areas of Riverside County. Acceptance of this funding will allow this program to continue for a fourth year and expand the number of children it reaches.
