8 **WHEREAS**, pursuant to Section 970.5 of the Streets and Highways Code, a
9 public hearing after due notice has been held upon a resolution of intention to change
10 the name of **Airport Drive** lying between Winchester Road and Sky Canyon Drive, as
11 granted to the County of Riverside by easement recorded on July 2, 1986, as
12 Instrument No. 154436, records of the Recorder of Riverside County, California, in
13 Section 7, T.7S., R.2 W., S.B.M., Third Supervisorial District, to **Sparkman Way**, and
14 all persons having had an opportunity to be heard; now, therefore;

15 **BE IT RESOLVED, DETERMINED AND ORDERED** by the Board of
16 Supervisors of the County of Riverside, State of California, in regular session
17 assembled on November 15, 2005, that the name of **Airport Drive** be
18 changed to **Sparkman Way**.

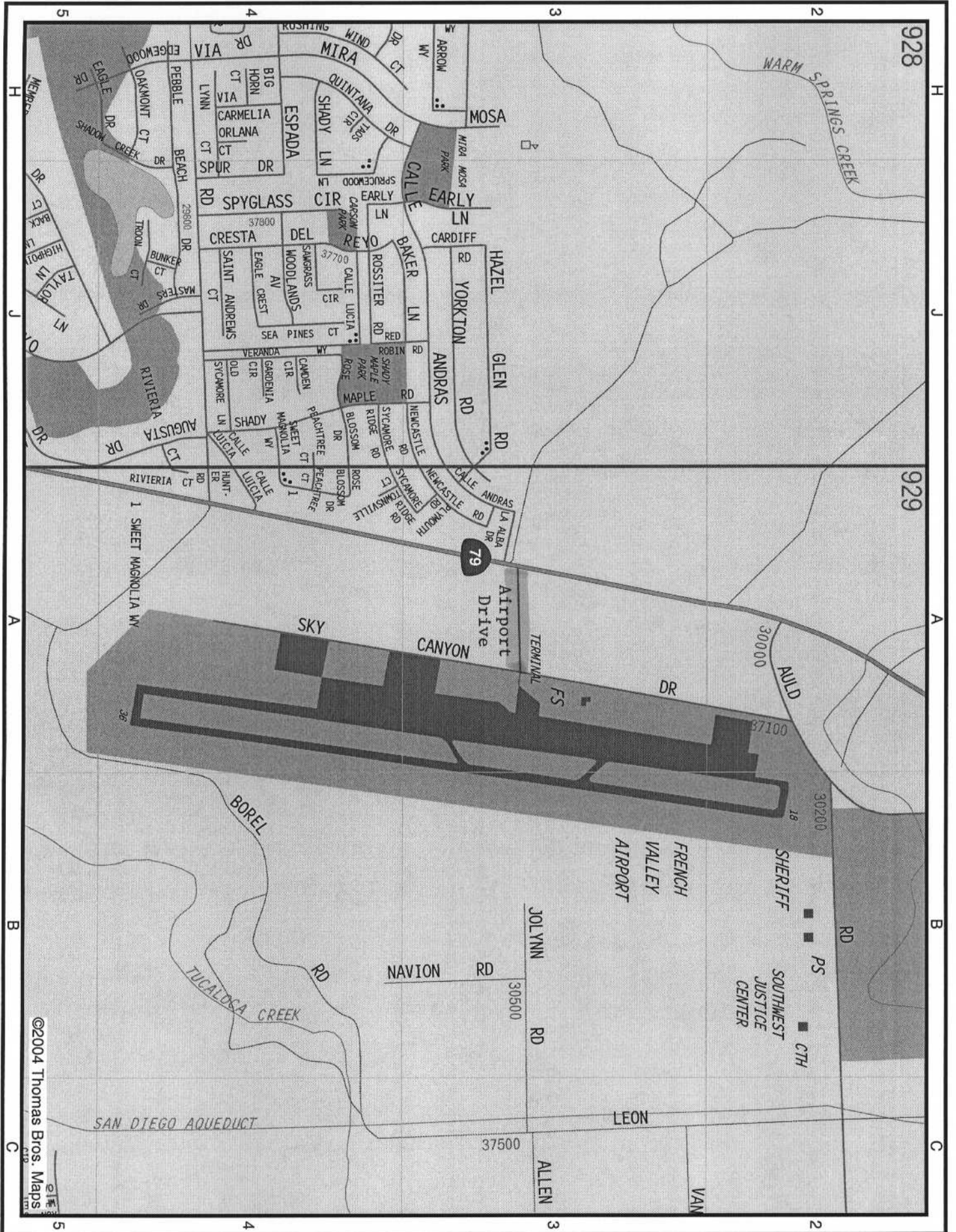
