SUBJECT: Approve First Amendment of the FY 2005/2006 Managed Care Consolidation Agreement with the State Department of Mental Health

(BACKGROUND CONT'D.)

Under Medicaid Managed Care (MMC) regulations, effective June 14, 2002, Mental Health Plans (MHPs) included in the Medi-Cal managed care program administered by the State Department of Mental Health (DMH) are considered Prepaid Inpatient Health Plans (PIHPs) and are required to comply with MMC regulations that apply to PIHPs. Medi-Cal, California's Medicaid program, is administered by the California Department of Health Services (DHS). The Medi-Cal managed mental health care program is administered by DMH via an Interagency Agreement with the Riverside County Department of Mental Health (DOMH).

The purpose of this amendment to the contract is to revise the amount of the contract to increase the interim allocation amount to reflect the final allocation amount based on the FY 2005-06 State budget. No County funds are required.
