**SUBJECT:** Graffiti Abatement Program – Acquisition of Vans

**RECOMMENDED MOTION:** That the Board:

1. Approve the purchase of two graffiti abatement vans from Dispensing Technologies Corporation;
2. Allocate \$212,000 in Redevelopment Funds to purchase the vans; and,
3. Find that, because of the magnitude and severity of the graffiti within the project areas, the action is necessary to effectuate the purposes of the redevelopment plan, and that the action will assist with the elimination of blight.

**BACKGROUND:** On November 15, 2005, the Board approved the implementation plan for an extended graffiti abatement program throughout the county's unincorporated areas. The plan included the acquisition of two graffiti abatement vans at a cost of approximately \$110,000 per van. An extensive bid solicitation process was undertaken by the County Purchasing Department, and one bid was received from Dispensing Technologies Corporation (DTC) for \$100,673 per van. After thorough review of the bid and similar requests for bid issued by other cities and counties, it has been determined that the bid received from DTC is reasonable and acceptable. In requests for bid issued by other cities, there has been only one other company to bid on graffiti abatement vans. The cost submitted by that company was 25% higher than that of DTC in that instance. It is recommended that the Board approve the acquisition of the vans from DTC.
