**SUBJECT:** Intent to Establish an Extended Services Benefit Zone within County Service Area No. 152

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Adopt Resolution No. 2005-025, Notice of Intent to Establish an Extended Service Benefit Zone within County Service Area 152, setting a public hearing for May 24, 2005, to create Benefit Zone "Cajalco Corridor"; and
2. Direct the Clerk of the Board to set and publish a notice for the public hearing on May 24, 2005, at 9:30am.

**BACKGROUND:** On January 25, 2000 the Board of Supervisors authorized adding the extended services of Park and Recreation Services within CSA 152. Government Code 25210.8 enables the Board of Supervisors to establish zones within any county service area with tax rates, service charges or benefit assessments varying with the extent of benefit to each zone. Increased development warrants the creation of a Benefit Zone to provide for extended services within the specified geographical location described in Exhibit "A".

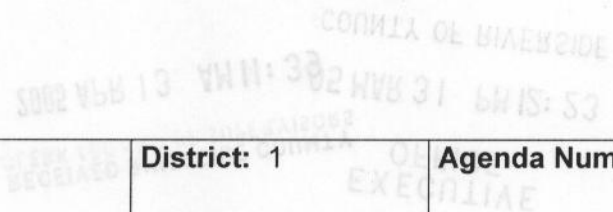

3 NOTICE OF INTENT  
4 TO ESTABLISH AN EXTENDED SERVICES BENEFIT ZONE WITHIN  
5 COUNTY SERVICE AREA NO. 152 CAJALCO CORRIDOR

6 **WHEREAS**, the Board of Supervisors has added extended services within County Service  
7 Area No. 152; and

8 **WHEREAS**, Government Code 25210.8 enables the Board of Supervisors to establish  
9 zone within any County Services Area, with tax rates, services charges or benefit assessments  
10 varying with the extent of benefit to each zone; and

11 **WHEREAS**, it is appropriate that a Benefit Zone be created for extended services in the  
12 unincorporated areas of Lake Mathews and Mead Valley.

13 **NOW, THEREFORE**, be it resolved by the Board of Supervisors of the County of  
14 Riverside, State of California, in regular session assembled on April 19, 2005 that a public  
15 hearing shall be conducted by this Board on May 24, 2005 to determine whether the extended  
16 services Benefit Zone "Cajalco Corridor" should be established within County Services Area No.  
17 152, as described in Exhibit "A" attached hereto; and

18 **BE IT FURTHER RESOLVED** that such extended services Benefit Zone "Cajalco  
19 Corridor" shall be within the unincorporated areas of Lake Mathews and Mead Valley, and that  
20 such payment for said extended services shall be made from parcel assessments collected  
21 pursuant to Section 25210.77(a) of the Government Code.

22 **BE IT FURTHER RESOLVED** that the Clerk of the Board is to give notice of the  
23 proposed public hearing pursuant to Government Code 25210.33
