RECOMMENDED MOTION: **APPROVE** the Cooperative Agreement between the County of Riverside, The Riverside County Flood Control and Water Conservation District, (District) and Standard Pacific Corp. (Developer); and **AUTHORIZE** the Chairman to execute the Agreement documents on behalf of the County.

BACKGROUND: The Agreement sets forth the terms and conditions by which certain stormwater drainage facilities, required as a condition of approval for Tract No. 29677-1, are to be constructed by the Developer and inspected, operated and maintained by the County and the District.

The Agreement is necessary to formalize the transfer of necessary rights-of-way and to provide for District construction inspection of the Eastvale - Gannett Street Storm Drain associated with Tract No. 29677-1.
