**BACKGROUND:**

On August 1, 2002 under RFP#97899 Prevent Child Abuse Riverside County recommended to the County of Riverside, Department of Public Social Services that Catholic Charities receive funding under the Promoting Safe and Stable Families Family Preservation Program. Through this funding Catholic Charities provides parenting education and counseling services to families that are at-risk and/or low risk of reoccurrence of child abuse and/or neglect to prevent the removal of children from their homes.

An increased need for bilingual-Spanish speaking counseling services has attributed to an influx of clients to Catholic Charities Riverside County counseling sites in Mecca, Indio, Cathedral City, Palm Desert, Metro, and Valley regions. Based upon the current service levels, it was determined that one-time PSSF Augmentation funds should be allocated to Catholic Charities in order for them to continue to provide counseling services through the end of this fiscal year. This amendment will increase Catholic Charities' Agreement by \$34,224, and will allow them to provide an additional 552 one-hour counseling sessions to these under served families.
