SUBJECT: APPROVE THE PROFESSIONAL SERVICE AGREEMENT WITH BARRY'S SECURITY SERVICE, INC. FOR UNARMED SECURITY GUARD SERVICE FOR THE MENTAL HEALTH INPATIENT TREATMENT FACILITY LOCATED IN RIVERSIDE COUNTY.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve and execute the personal service agreement with Barry's Security Service, Inc. for an annual amount not to exceed \$230,000, and;
- 2) Authorize the Director of Purchasing to sign amendments and exercise renewal options for up to three (3) additional one-year increments for an amount not to exceed the contract maximum and;
- 3) Direct the Clerk of the Board to file one executed copy and return three (3) original signed copies to Purchasing and Fleet Services.

BACKGROUND: RCRMC, Mental Health Inpatient Treatment Facility provides in-patient mental health treatment services and the security guard service is required to ensure a safe, calm, secure, peaceful environment for employees and patients, and to provide protection for the buildings, their contents and guard against theft, pilferage and vandalism on the premises. These services are provided with a minimum of two security officers, twenty-four (24) hours a day, seven (7) days per week, and three hundred sixty-five days a year.

PRICE REASONABLENESS

On Behalf of RCRMC, County Purchasing issued a formal Request for Proposal (RFP), PUARC502 for Unarmed Security Guard Services for the RCRMC Mental Health Inpatient Facility. Solicitations were sent to fourteen vendors and advertised on the Riverside County Purchasing Web Site. Six responsive proposals were received and evaluated by RCRMC staff. Barry's Security Service was the lowest cost responsive/responsible proposal received, and meets the requirements set by the County.

REVIEW/APPROVAL

This procurement was reviewed and approved by the County Purchasing Agent.

FINANCIAL IMPACT

The current fiscal year cost is for the two remaining months of the fiscal period ending 6/30/05, in the amount of \$38,333.34.

The maximum amount of this Agreement is \$230,000.00 annually.
