BACKGROUND (Continued):

This Amendment to the Agreements with Drs. Susan Horowitz and Lorena Vivanco De Martinez will provide extended professional service coverage to the Hospital's Child Abuse and Neglect (CAN) Program that will enable the Hospital to provide added days of physician coverage to the CAN Program and ensure services are available on a more consistent basis for the County.

The funds provided under this Agreement, outlined in Schedule A, are provided by the Department of Public Social Services to be used for the development of the Riverside County-Wide Child Abuse and Neglect program services.
