BACKGROUND contd.:

The selection of firms followed Policy H-7 requirements, including solicitation of Statements of Qualifications and subsequent oral interviews. Fees paid to a listed consultant must be less than \$100,000 for an individual project, or a maximum of \$100,000 during any fiscal year. The approved list will remain valid for a period of three years, at which time the selection process will be reinitiated.
