**SUBJECT:** High Pressure Self-Contained Breathing Apparatus (SCBA) Project

**RECOMMENDED MOTION:** That the Board:

- 1) Accept the 04/05 Federal Emergency Management Agency (FEMA) funds awarded to Riverside County Fire Department's (RCOFD) High Pressure Self-Contained Breathing Apparatus (SCBA) project;
- 2) Authorize the Auditor Controller to make the budget adjustments as shown in Schedule A.

**BACKGROUND:** On September 14, 2004 (3.33), the Board accepted grant funding for RCOFD's High Pressure Self-Contained Breathing Apparatus (SCBA) Project. RCOFD promised the Board that it would pursue additional funding to purchase the remaining SCBAs. On April 1, 2005, Secretary Michael Chertoff announced 22 grants to fire departments throughout the United States in the fortieth round of the Fiscal Year 2004 Assistance to Firefighters Grant Program. Riverside County Fire Department (RCOFD) received one of these grants in the amount of \$1,067,800 for the SCBA Project. The grant has a 70/30 cost share requirement as follows: 70% federal (\$747,460) and 30% non-federal (\$320,340). RCOFD will utilize previously appropriated non-federal Tribal gaming funds to cover the required match.
