**RECOMMENDED MOTION:** (Continued)

2. Authorize the Director of the Department of Facilities Management or his designee to complete the adoption pursuant to County Code 9.44, Prohibiting Skateboarding on County-Owned Properties in the City of Riverside; and

3. Authorize the Clerk of the Board to publish pursuant to Section 6061 of the Government Code.

**BACKGROUND:** Riverside County Code ("RCC") Chapter 9.44 (Riverside County Ordinance 792 adopted in 1999) prohibits skateboarding in any specific area of public property that has been identified in a Resolution adopted by the Board of Supervisors.

The Director of the Department of Facilities Management ("Department"), formerly known as the Building Services Department hereby recommends, as required in RCC Section 9.44.030 that the Board of Supervisors designate all County owned properties located within the City of Riverside designated on Exhibit "A" attached hereto, as a "No Skateboarding, Rollerblading or Similar Activity Area".

The Department shall post signs as required in RCC Section 9.44.040.

5 PROHIBITING SKATEBOARDING ON COUNTY OWNED PROPERTY IN THE

7 WHEREAS, the Riverside County Code ("RCC") Chapter 9.44 (Riverside County  
8 Ordinance No. 792) prohibits skateboarding on any public property, as defined in the Code,  
9 when such property is located within territory subject to jurisdiction of the County of Riverside  
10 ("County") and the Board of Supervisors of the County has adopted a resolution under RCC  
11 Section 9.44.030 stating that the Code shall apply to such specifically identified property as  
12 specified in the Resolution and the property has been posted with signs advising of the  
13 application of the County Code provisions prohibiting skateboarding on such property; and,


14 WHEREAS, in accordance with RCC Section 9.44.030, the Director of the Department  
15 of Facilities Management for the County has recommended to prohibit at all times  
16 skateboarding, rollerblading and similar activity on County owned properties located within  
17 the City of Riverside as designated on Exhibit "A" attached hereto; and,

18 NOW THEREFORE BE IT RESOLVED, by the Board of Supervisors of the County of  
19 Riverside, State of California, in regular session assembled on January 10, 2006 that  
20 skateboarding, rollerblading or similar activity shall be and is hereby prohibited at all times on  
21 the County owned properties located within the City of Riverside, designated on Exhibit "A"  
22 attached hereto and made a part hereof, and the County will post signs advising persons of  
23 the application of RCC Chapter 9.44 prohibiting skateboarding in violation of the Code  
24 provisions with such notification being given in the manner required by the language of RCC  
25 Section 9.44.040.
