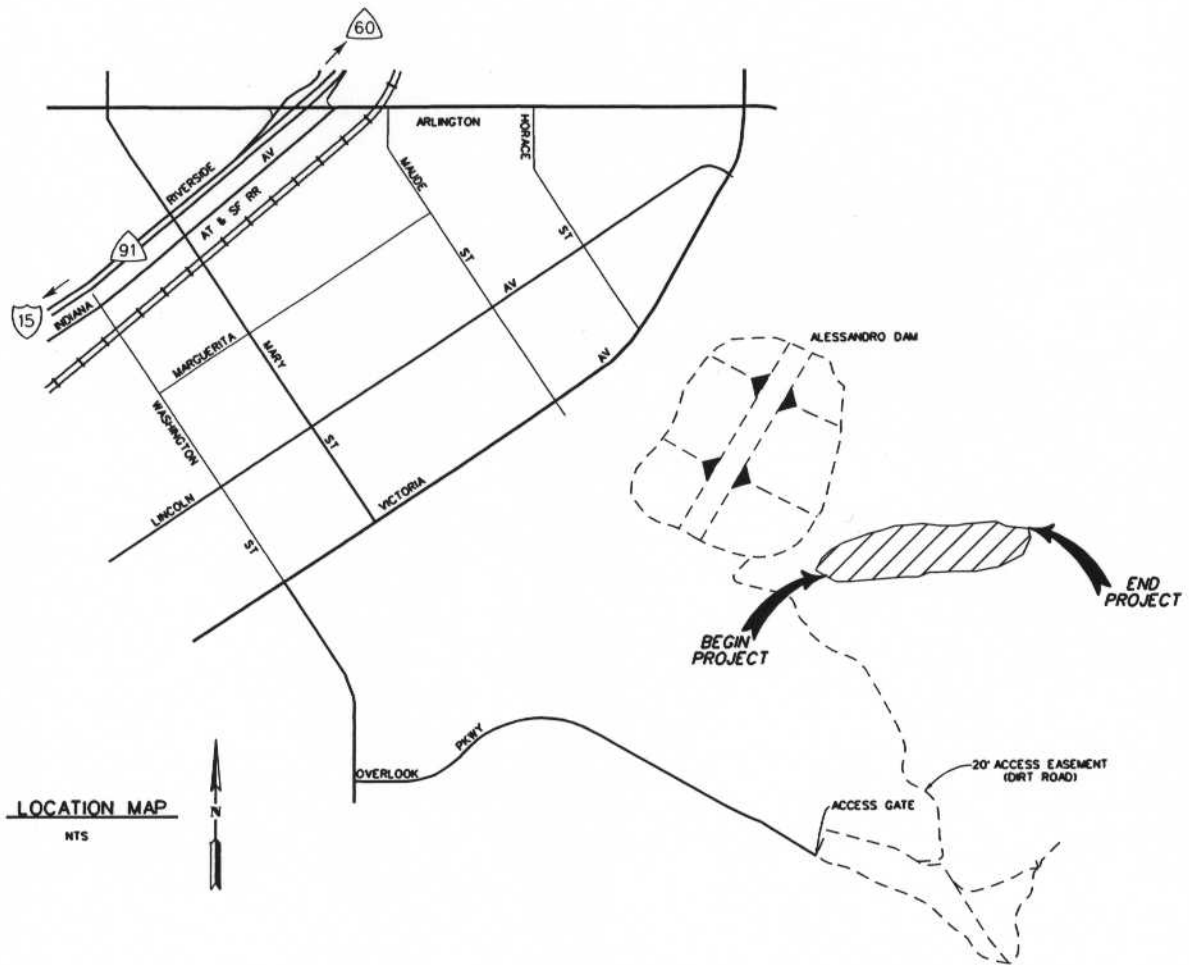

BACKGROUND:

The Board approved the original contract with Grand Pacific Contractors, Inc. as Agenda Item Number 11.1 on July 26, 2005 in an amount of \$222,500.00. The District is in receipt of unsubstantiated requests for addition compensation for increased contract quantities of Sediment Removal in an amount of \$70,000.00 which is a contract increase of 32%. The total project construction cost is estimated not to exceed \$292,500.00, including all the costs associated with the claims for additional compensation.

Final inspection of the above referenced project was made, and the project was found to be complete according to plans and specifications. A brief project description and location map are attached.

This project consists of the removal of approximate 21,000 cubic yards of sediments behind the dam.
