**SUBJECT:** Notice of Completion – Construction of Roadway Drainage Improvements on Van Buren Boulevard, from Approximately 330 Feet West of Regency Ranch Road to Approximately 720 Feet Westerly, and Construction of Median Island Improvements on Van Buren Boulevard, Fred Street to 350 Feet Easterly, Woodcrest/Riverside area

**RECOMMENDED MOTION:** That the Board execute and file the attached "Notice of Completion"

**BACKGROUND:** By Minute Order 3.42 of March 15, 2005, the Board entered into an agreement with Hillcrest Contracting for the construction of roadway drainage improvements on Van Buren Boulevard, from approximately 330 feet west of Regency Ranch Road to approximately 720 feet westerly, and construction of median island improvements on Van Buren Boulevard, Fred Street to 350 feet easterly, in the Woodcrest/Riverside area of Riverside County. The authorized amount of the contract was \$138,935.00. The total amended contract amount (including Change Orders, liquidated damages and quantity adjustments) is \$148,888.63, which is 7.2% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on August 30, 2005. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Orders A7-0326 and B10-626.

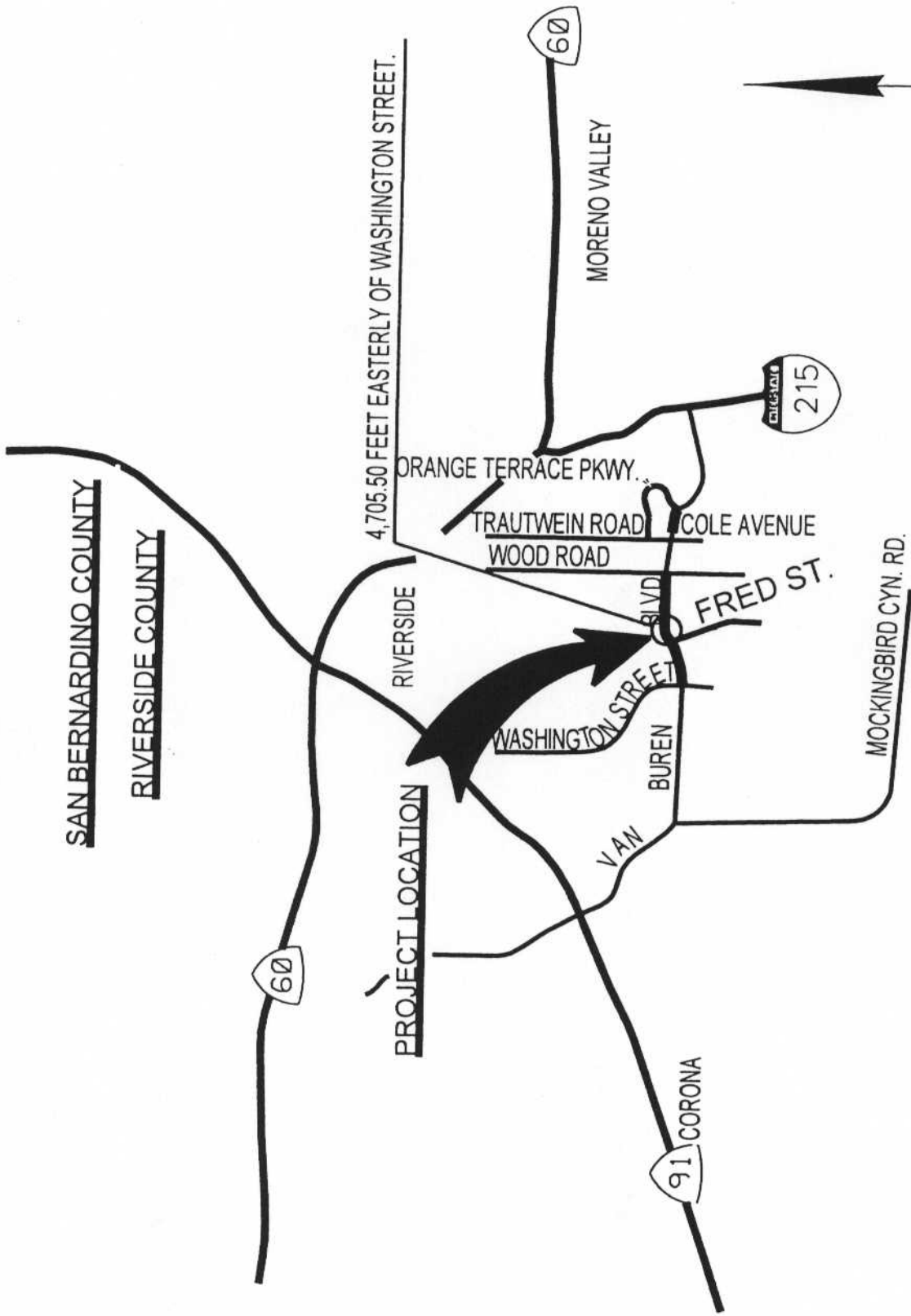
