**BACKGROUND:** By Minute Order 3.22 of June 14, 2005, the Board entered into an agreement with Dye and Browning Construction, Inc. for the construction of sidewalk, curb and gutter and access ramps, on the east Side of Almond Street, Canyon Drive to Walnut Street in the Lake Elsinore area of Riverside County. The authorized amount of the contract was \$123,200.00. The total amended contract amount (including Change Orders and quantity adjustments) is \$120,934.77, which is 1.8% less than the originally authorized amount.

This work was completed in conformance with the plans and specifications on November 21, 2005. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order B4-0510.

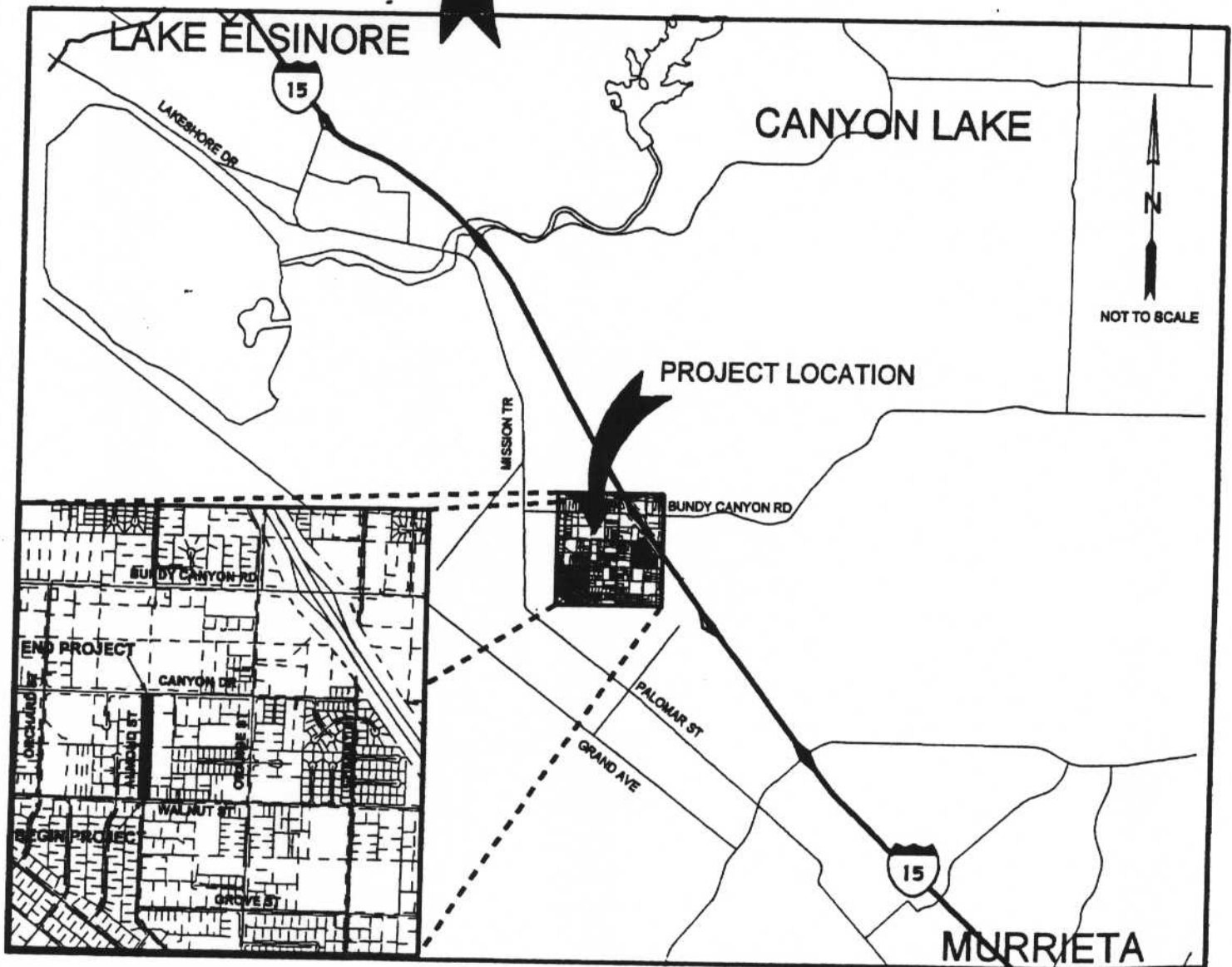
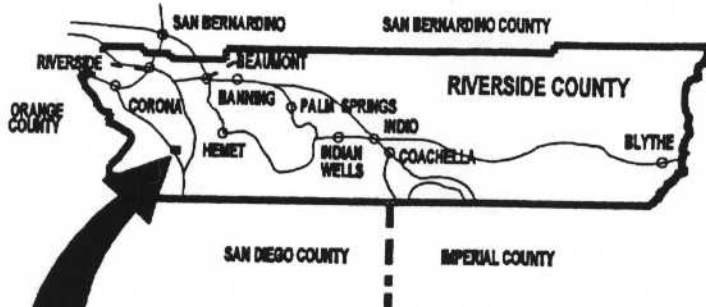
