SUBJECT: Acceptance of a Workers' Compensation Insurance Fraud Grant

RECOMMENDED MOTION: That the Board of Supervisors:

1. Accept a \$669,034 Workers' Compensation Insurance Fraud Grant award from the Insurance Commissioner of the State of California for the grant period July 1, 2005 through June 30, 2006.
2. Approve and direct the Auditor Controller to make budget adjustments as shown in Attachment A.

BACKGROUND:

The Insurance Commissioner of the State of California has renewed the Workers' Compensation Insurance Fraud grant for the July 1, 2005 through June 30, 2006 grant period. The grant, awarded under the provision of section 1872.83 of the California Insurance Code, is to be used by the District Attorney solely for the purpose of enhanced investigation and prosecution of workers' compensation fraud cases.
