SUBJECT: 2nd Amendment to the Professional Medical Services Agreement between the County of Riverside and Loma Linda University Urology Medical Group, Inc.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the 2nd Amendment to the Professional Medical Services Agreement, effective January 1, 2006;
- 2) Authorize the Chair person to sign three (3) copies of the Agreement; and
- 3) Retain one (1) copy and return two (2) copies of the executed Agreement to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: On August 13, 2002, Agenda Item No 3.48 an Agreement was approved for the provision of comprehensive urology professional medical services for the patients at RCRMC. The Agreement was first amended May 11, 2004 Agenda Item No. 3.25 extending the term of the Agreement. This 2nd Amendment adds *extracorporeal* shock wave (ESWL) lithotripsy professional services to the Agreement and provides an increase to yearly compensation based upon the average CPI increase for the remaining term of the Agreement.


This Amendment has been approved as to form by Riverside County Counsel.


