SUBJECT: Notice of Completion – Construction of Traffic Signal, Lighting and Road Improvements at State Route 74 and Palomar Road, Romoland area

RECOMMENDED MOTION: That the Board execute and file the attached "Notice of Completion"

BACKGROUND: By Minute Order 3.40 of February 24, 2004, the Board entered into an agreement with R. J. Noble Company for the construction of traffic signal, highway lighting and associated improvements at the intersection of State Route 74 and Palomar Road, including the construction of the permanent closure of the Ethanac Road connection to State Route 74, in the Romoland area of Riverside County. The authorized amount of the contract was \$327,912.00. The total amended contract amount (including Change Orders and quantity adjustments) is \$356,581.24, which is 8.74% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on September 2, 2004. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order B4-0499.
