Background Continued:

On February 8, 2006 the Planning Commission approved the draft redevelopment plans and adopted final boundary areas for the proposed amendments to the I-215 Corridor Redevelopment Project Area. The next step is to establish a date, time and place for a public hearing that will allow property owners, residents, businesses, and affected taxing agencies in the Lakeview/Nuevo and Sun City/Quail Valley sub-areas to be notified of the public hearing and be given an opportunity to comment on the Redevelopment Plan Amendments and the Environmental Impact Reports. Notice of this public hearing will be filed with the Clerk of the Board and the hearing will be advertised in the local newspaper. Staff recommends approval of the attached resolutions.

RESOLUTION NO. 2006-12

A RESOLUTION OF THE REDEVELOPMENT AGENCY FOR THE COUNTY OF RIVERSIDE CONSENTING TO A JOINT PUBLIC HEARING WITH THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE ON THE REDEVELOPMENT PLAN FOR THE I-215 CORRIDOR REDEVELOPMENT PROJECT AREA, AMENDMENT NO. 1B – SUN CITY/QUAIL VALLEY SUB-AREA, AND ON THE ENVIRONMENTAL IMPACT REPORT PREPARED IN CONNECTION THEREWITH

WHEREAS, the Redevelopment Agency for the County of Riverside (the "Agency") has initiated an amendment to the Redevelopment Plan for the I-215 Corridor Redevelopment Project Area, Amendment No. 1b – Sun City/Quail Valley Sub-Area (the "Amendment"); and

WHEREAS, the Agency and the Board of Supervisors of the County of Riverside (the "Board of Supervisors") may hold a joint public hearing on the proposed Amendment; and

WHEREAS, Section 33349 of the of the Community Redevelopment Law, California Health and Safety Code Sections 33000 *et seq.* requires that a notice of said public hearing be published in a newspaper of general circulation and be mailed to each property owner, resident, business, and affected taxing agency.

NOW, THEREFORE, BE IT RESOLVED by the Redevelopment Agency for the County of Riverside as follows:
