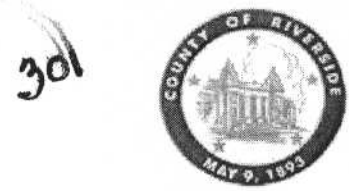

SUBJECT: Assignment and Delegation of Inland Mental Health Associates Inc., dba Canyon Ridge Hospital

RECOMMENDED MOTION: 1) Ratify and Approve the attached Assignment and Delegation from Inland Mental Health Associates Inc., dba Canyon Ridge Hospital, an acute care behavioral medicine facility located in Chino, to Canyon Ridge Hospital, Inc. effective August 1, 2005; 2) Authorize the Chairperson to sign four (4) copies of the attached Agreement; and, 3) retain one (1) copy of the signed Agreement and return three (3) copies to Human Resources for distribution.

BACKGROUND: In 1999, the Board of Supervisors established the County's self-funded Exclusive Provider Option (EPO) health plan, Exclusive Care, to provide a value health plan option to the employees of Riverside County and their families. To provide services to its enrolled members, Exclusive Care has contracted with a variety of healthcare providers.

BACKGROUND (CONTINUED):

This Assignment and Delegation is the result of a legal restructuring of the Canyon Ridge Hospital and allows Inland Mental Health Associates, Inc., the legal entity holding the contract with Exclusive Care, to assign and delegate the contract to Canyon Ridge Hospital, Inc., the new legal entity owning the hospital, effective August 1, 2005. This allows Canyon Ridge Hospital Inc. to continue the hospital's participation in the Exclusive Care Provider Network under terms similar to other comparable providers under contract.
